

A report on South Carolina's use of COVID-19 federal relief funds for child care 2020 - 2024









Making a difference in South Carolina's child care sector

In 2020, the COVID-19 pandemic had a profound impact on families and businesses nationwide, especially in the child care sector. Several child care programs were forced to permanently close or decrease enrollment due to staff shortages. As a result, parents struggled to find care for their children while continuing to work.

In response to the economic impact of the pandemic, federal relief funds were allocated to states to help stabilize the child care sector.

South Carolina received nearly \$955 million in such funds, which was managed by the South Carolina Department of Social Services Division of Early Care and Education. Allocated through the Coronavirus Aid, Relief, and Economic Security (CARES) Act, the Coronavirus Response and Relief Supplemental Act (CRRSA), and the American Rescue Plan Act (ARPA), these funds were intended to stabilize the child care sector, help families, and ensure that South Carolina's child care programs continue to provide affordable, accessible, and high-quality care.

This document provides an overview of how the South Carolina Department of Social Services used these funds to address the challenges faced by child care providers, support families, and promote long-term improvements in child care infrastructure across the state.

Federal relief funds for child care

Coronavirus Aid, Relief, and Economic Security (CARES) Act

The Coronavirus Aid, Relief, and Economic Security (CARES) Act, signed into law on March 27, 2020, was a stimulus bill aimed at combating the economic effects from the COVID-19 pandemic. Through the CARES Act, funds were allocated to states, tribes, and territories to help keep child care programs open to serve children and families.



South Carolina received \$63.6 million in CARES Act funding to help child care providers

Coronavirus Response and Relief Supplemental Act (CRRSA)

The Coronavirus Response and Relief Supplemental Act (CRRSA), passed in December 2020, included provisions for child care to help support families and providers affected by the COVID-19 pandemic. It allocated funding to assist child care programs with operational costs, ensure access to care for essential workers, and help families facing economic challenges. Through CRRSA, South Carolina offered five rounds of grants to child care providers.

American Rescue Plan Act (ARPA)

In March 2021, the American Rescue Plan Act (ARPA) was signed into law. ARPA provided direct relief to individuals, businesses, and state and local governments in response to the economic impact of the COVID-19 pandemic. South Carolina received ARPA funding for child care on April 15, 2021, which was divided into Child Care Stabilization Funds and Supplemental Discretionary Funds.

From 2021 to 2023, these subsidies helped 3,215 children for a total of \$11 million







GRANT SPOTLIGHT: SC BOO\$T

Funded through ARPA



SC BOO\$T was a pilot program that provided bonuses directly to qualified individuals employed in child care facilities in South Carolina. This was a unique chance for child care professionals to receive supplemental wages while doing the job they love using a limited, one-time source of federal money. The program was created in response to data revealing low wages for the early childhood workforce. We are working to help bridge the gap in the wage discrepancy for the early care and education workforce. SC BOO\$T is administered by the South Carolina Department of Social Services' SC Endeavors program.

Eligibility

The pilot program was available for the following child care professionals:

- Teacher
- Co-Director
- Assistant Director Assistant Teacher
- Director
- Floater
- Non-Teaching Professional Staff
- Non-Teaching Support Staff
- Primary Care Provider
- Aide
- Curriculum Coordinator

Note: Substitutes, volunteers, and interns did not qualify for SC BOO\$T.

To qualify for SC BOO\$T, child care professionals had to meet the following criteria:

- · Work in a DSS regulated program
- Be employed within the same program for 6 months or more
- Be in a direct care position
- · Have verified employment within the registry
- Have current SC Endeavors Registry Career Ladder level
- Complete the salary/wage information in the SC Endeavors registry
- Earn equal to or less than \$24 per hour for direct care staff. Directors, owners or family/group providers can earn equal to or less than \$30 per hour.

Funding Amounts

Amounts were distributed per the SC Endeavors Registry Career Ladder level and were divided between two 6-month payments. If applicants continued to meet the eligibility requirements, the payment were automated.

The SC Start-Up Child Care (SUCCess) Grants were developed to provide support through training and technical assistance during the first six to 12 months of operation to eligible applicants. As milestones are met, financial incentives can be obtained to support and ensure the program's participation in professional development opportunities and individualized coaching. Accepted applicants could increase their financial stability by completing set goals, and maintaining business and regulatory standards as they continued to work towards continual quality improvement for their new program. Applicants were encouraged and supported in their application to the ABC Quality program.

Eligibility

To qualify for the SUCCess Grant, prospective providers had to meet the following criteria:

- Not be a child care program associated with a chain, franchise, or other larger organization that provides support through funding, resources & materials, or physical space.
- Ensure all information submitted through the application is complete and true
- Agree to the terms and conditions of the work required for the SUCCess Grant project
- Ensusre providers, co-owners, partners, and/or director(s) have never had a child care license revoked or denied by DSS Child Care Licensing or any other state licensing or child care regulatory agency
- Attend the DSS SC Child Care Licensing Orientation meeting and the SUCCess Grant introductory meeting

Approved Use of Funds

All funds awarded to participants must be used for expenses related to the child care program and within these general categories:

- Personnel Costs
- Rent/Lease, Utilities, Business Insurance
- Facility Maintenance & Improvement
- Furniture, Fixtures, & Equipment
- Consultant, Planning, or Service Fees

- Educational Supplies and Classroom Equipment
- Playground & Outdoor areas
- Marketing Fees
- Technology

4-Tier Process

Funding was divided into four tiers. Participants had to complete all requirements in each tier to receive payment and approval, and to move to the next tier. Each approved participant will be assigned a Child Care Licensig (CCL) Specialist and SC Child Care Resource & Referral (SC CCR&R) Quality Coach (QC) to help provide support, resources, and guidance throughout the project. All completed tier requirements will be approved by CCL and SC CCR&R before funds are distributed.

What is ABC Quality?

ABC Quality is South Carolina's only rating and improvement system for child care and early education. While licensing sets standards for health and safety, ABC Quality is voluntary for child care programs and promotes excellence in meeting the total needs of children.

Expect the highest quality services of programs participating in ABC Quality. Every program that has earned a rating does more than provide the basics. Having a letter rating (of any level) is proof a program goes above and beyond to provide the kind of child care children need to thrive.



The ABC Quality Levels





Consistently and effectively promotes quality practices. Awarded the highest quality standard score.





Demonstrates strategies to increase program quality. Awarded a high quality standard score.



Meets health and safety requirements. Quality standards exceed licensing requirements.



Quality score is pending. Provider meets pre-requirements and can accept child care scholarships.



Legally exempt programs serve children age 5 and up and are open less than 4 hours daily or on school holidays. If a program has both an E rating and an A/B/C quality level rating, all ABC Quality eligibility criteria have been met.
